**During the 2015 fiscal year, MedShare collected 1,692,629 pounds of reusable medical supplies and equipment and used 19,000 volunteers to deliver 137 shipments valued at \$19 million to 28 countries. It should be noted that the drop in net assets for MedShare's fiscal year of \$3,087,910 was solely attributable to the change in the Gift-in Kind inventory value. During the year MedShare received fewer Gift-in-Kind inventory contributions than the prior year, shipped more Gift-in-Kind inventory out than the prior year, and recycled a large amount of unsuitable inventory.
