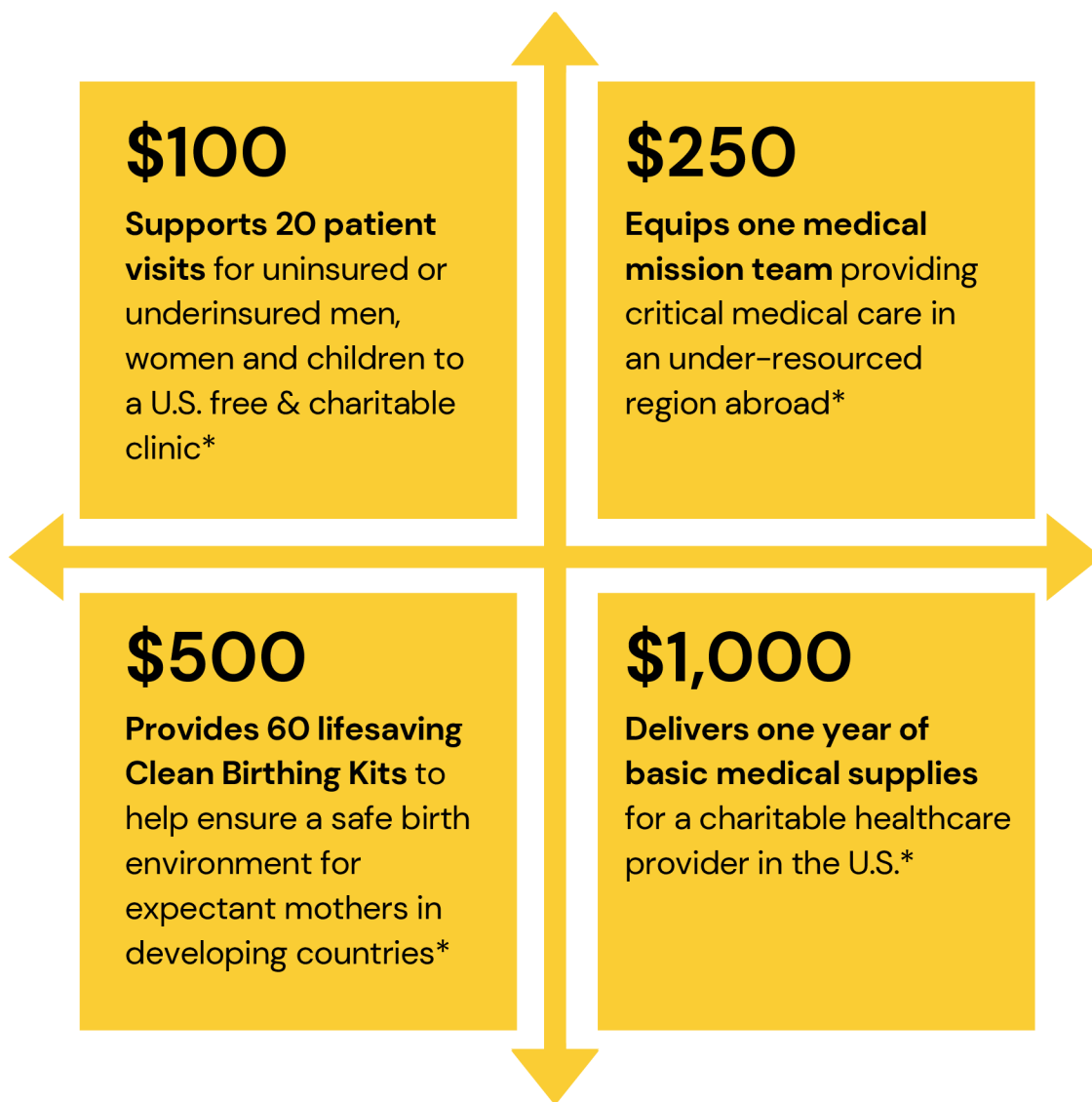

DEMONSTRATED IMPACT

Helping to Improve Maternal & Child Health Outcomes

Across the U.S. and around the world, maternal and child health is facing a crisis – particularly in underserved communities where resources are limited and demand is growing. So MedShare has again stepped up.

In 2024–25 alone, MedShare supported hundreds of vulnerable health systems that serve communities where access to maternal health services is limited or nonexistent, including:

- Donating 92 portable ultrasound machines to 80 free and charitable clinics across 30 U.S. states, along with invaluable training on installation, use, and maintenance
- Working with our partners to continue to help reduce alarming maternal and infant mortality rates in Nigeria and Côte d'Ivoire through our Safe Birth Initiative (SBI)
- Donating OB/GYN exam tables, other diagnostic tools to support prenatal screenings and neonatal equipment to care for premature and low-birthweight infants
- Delivering thousands of Clean Birthing Kits stocked with medical supplies necessary to ensure a safe, sterile environment for mothers whose only option is to give birth outside of a medical facility

Strengthening America's Healthcare Safety Net

As free and charitable clinics across the country continue to grapple with financial uncertainty, MedShare remains steadfast in our support. By helping clinics save every possible dollar on medical supplies and equipment, MedShare helps ease the burden of impossible choices: like whether to keep the lights on or provide the standard of care their patients deserve. MedShare continues to grow the number of charitable providers we support – shipping medical supply orders to clinics across 36 states as we prioritize under-resourced clinics in the 20 states with the lowest healthcare outcomes.



Investing in Immediate Response & Long-Term Recovery

Through our year-round preparedness efforts and active partnerships, we not only deploy emergency medical supplies and equipment in the aftermath of a disaster but continue to support these communities as they rebuild their healthcare infrastructure over time. Not only are we currently responding to region of the Caribbean devastated by Hurricane Melissa, MedShare continues to support the long-term healthcare needs of the people of Ukraine.

CUMULATIVE IMPACT

- **34 million lives** impacted by MedShare across **120 countries** since 1998
- **Over 1 million healthcare professionals** equipped and/or trained worldwide by MedShare
- **Millions of pounds of valuable medical supplies & equipment** diverted from landfills to charitable healthcare providers to help save lives
